Following the 2015 Annual General Assembly Meeting (AGM) held on Sept 18, 2015 in Barcelona, Spain, the Secretary prepared and emailed Minutes of the meeting to the Officers, Board of Directors and Country representatives for comments, additions and corrections. Some minor comments were received and I revised the Minutes and circulated. It was sent to the President-Elect to be put on the IFEA website.

The Secretary also interacted with the Country Contacts and IFEA Regents. Additionally, Endodontic Club of United Arab Emirate (Zuhair Alkhatib) contacted our Organization through our President and expressed their interest in joining the membership of IFEA and hosting WEC. The Secretary provided them all the information through the email.

For nomination of the Officers and Regent Directors, the Secretary called for nomination and some nominations were submitted. However, some Regent positions are still waiting for nomination.

For the preparation of this Meeting, the Secretary contacted Organizing Committee of the 10th WEC, South Africa for our meetings. Confirmation of the time and venues for IFEA meetings were set and the Secretary has announced it three times.

The Secretary has announced the application for the bid of 13th World Endodontic Congress which will be held in 2022. South Korea, United Kingdom and Portugal Endo societies submitted their applications for this.

Finally, I have happily enjoyed this executive position with President Sam Dorn, President-Elect Mark Wotzke, Treasurer Catherine Ricci, and Immediate Past President Patrick Bogaerts, who have been actively working to keep and improve our organization with deep insights so as to improve the endodontics in the world.
