### **Old Business -**

**Web Site:** Web site was renovated with the sponsorship by Sybron Endo. Future plans call f or archives with all minutes, reports and history, and to link to the web site of the member s ocieties, and to show the calendar of future international meetings of possible interest to o ur members and to avoid conflicts when possible.

**Dues Payment:** There are now 5 societies out of 31 member societies that have not paid th eir dues to this time, being the associations from Argentina, Brazil, India, Iran and Israel.

**IFEA/AAE interaction:** Executive Committee of IFEA had joint meeting with the Executive Committee of AAE on April 19<sup>th</sup> 2012. IFEA Officers requested AAE 's assistance with obta ining CERP recognition to be able to provide CE credit to American dentists attending the I FEA congress, and suggested to provide AAE with a link to the registration site for their m eeting, to be posted on aae.org.

For CERP/CPD requirement from member countries: Information was gathered from Austral ia, Belgium, New Zealand and USA on the requirements to receive Continuing Professional Development (CPD) or Continuing Education Recognition Program (CERP) credits.

Bureau of speakers was not used at all during the past 8 years and there has been no request. Therefore it was suggested to be deleted.

### **New Business -**

**New Members:** The Secretary informed that Portugese Society of Endodontology had already submitted the membership application before this meeting. This society will be accepted as provisional members awaiting payment of dues.

**Membership:** IFEA provisionally accepts new members with less than 100 dues paying members at the moment and the By-Laws can be **amended** at the next AGM to remove the number of members required for a society to join IFEA. The amendment of the IFEA By-Law needs to be preannounced before next AGM.

It is not necessary to translate into English the entire constitution of the country associ ation applying for the membership but only an English translation on who is eligible for membership in the Association applying for IFEA membership.

**Membership payment option**: Most members are paying the membership with credit card and some with bank transfer or check. Membership dues is \$360 for 2013 the same as 2012. When using electronic transfer all bank fees charged by the members' bank are to be paid by the association utilizing the ET.

**World Endodontic Congress:** A suggestion was to have IFEA World Congress every two years to avoid a conflict with European Society Meeting. But it was approved to keep the 3 y ears interval.

**A nomination** slate for new Officers was presented. Sam Dorn was nominated as the Pres. Elect. Therefore the Officers for 2012/13 are: Past Pres. - Joe Maggio, President - Patrick Bogaerts, Pres. Elect - Sam Dorn, Secretary – Luke Sung Kyo Kim, Treasurer -

Mark Wotzke.

A nomination slate for new Regents was presented. Manoel Edvardo (Merchado) was nom inated as the Regent for S. America. A new Regent for Africa will be recommended by the S outh African Society. Therefore the Regents for 2012/13 are: Asia - Hideaki Suda, Europe - Miguel Minana, N. America - Barry Chapnick, Oceania - Alan Nerwich, S. America - Manoel Edvardo (Merchado), Africa -

to be recommended. Committee Chairs are, Education - Sam Dorn, Research - Markus Haapasalo.

**Date and Place of next meeting:** The date of the next Board of Directors Meeting of IFEA was scheduled at the  $9^{th}$  WEC for May 23 ~ 25, 2013 in Tokyo.
